#### 2 STEPS TO BEGIN SYNCING YOUR DATA WITH NOURISH TO FLOURISH

#### 2.1 Implementation Steps

- 1. Review the attribute requirements in the Attribute Guide linked in Section 3 of this document to ensure you can meet the minimum attribute requirements. Please also note:
  - Nourish to Flourish requires all suppliers to populate "Does Trade Item Carry USDA Child Nutrition Label?" field and provide Child Nutrition Label information if available
  - Nourish to Flourish requires any suppliers that have Product Formulation Statement information for any of your products, to provide that information to Nourish to Flourish.
- **2.** Complete the **Supplier Partner** Form found on the Nourish to Flourish Data Synchronization Landing page at <u>Nourish to Flourish Landing Page</u>. This will enable Nourish to Flourish to create a subscription based on the Information Provider GLN submitted.
- **3.** Have your accurate item data loaded into your GDSN certified data pool and ensure it is ready for publication in Production. Contact your data pool for any education you might require completing this step.
- **4.** Nourish to Flourish will notify the primary data synchronization contact provided on the Supplier Partner Form via email when a subscription for your GLN has been created and they are ready to accept your item publications.

#### 2.2 Publication Steps

We recognize that suppliers are working hard to continuously update available attributes for publishing, including the new Child Nutrition (CN Label) related fields. We acknowledge this is a work in progress and subject to future systemic updates. We prefer to get the process started at the present time with the following steps.

- 1. Publish all items to the Nourish to Flourish GLN 0860206001702 as Initial Load
  - Nourish to Flourish asks that you publish as many items from your catalogue as possible.
  - Only active items will be synchronized; however, having your additional product information allows our buyers to see those items and select them for future purchases.

- Please include images and marketing information as these attributes will help us sell your product.
- If your products are published in a hierarchy, please publish from the highest hierarchy level.
- 2. Nourish to Flourish will use the following Catalogue Item Confirmation (CIC) messages:
  - A CIC of 'RECEIVED' will be sent when a publication is received.
  - If you receive a 'REVIEW' or 'REJECTED' status, please investigate and correct the item based on the feedback in the CIC message.
  - A CIC with the state of 'SYNCHRONIZED' will be sent after Nourish to Flourish successfully receives, updates and validates supplier data.
- **3.** Suppliers should continue to send changes and corrections for all items synchronized with Nourish to Flourish via their data pool.

#### 2.3 Catalog Item Confirmations (CIC's)

#### **CIC Messages:**

**RECEIVED:** Product has been received and has passed GDSN validations. This response will typically be sent within a few hours after receiving the publication.

**REVIEW:** Product does not pass GDSN validations or product has failed the Nourish to Flourish audit process and therefore has data discrepancies to be reviewed and addressed. Reason for Review status will be transmitted in CIC999. This response may follow a Received message and may take several days to resolve.

**SYNCHRONIZED:** Product has been fully accepted and loaded into Nourishto Flourish's internal system and will be updated as revisions occur. This response will be sent after all validations and audits have been successfully completed.

**REJECTED:** Nourish to Flourish no longer wants to sync this item to their internal system or item has been delisted by Nourish to Flourish.
